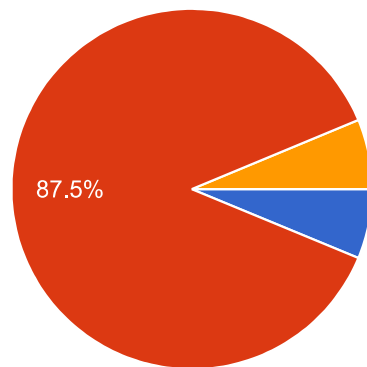

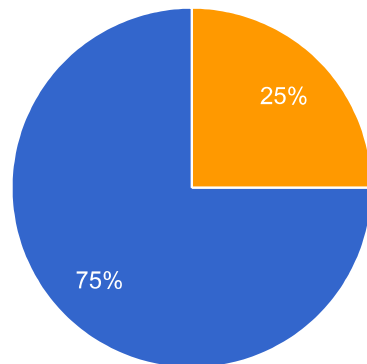


- A scores 2 points

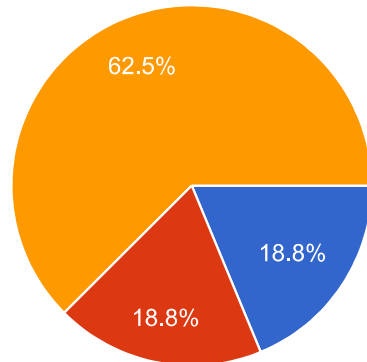
- A may choose to have the ball moved to the middle of the field

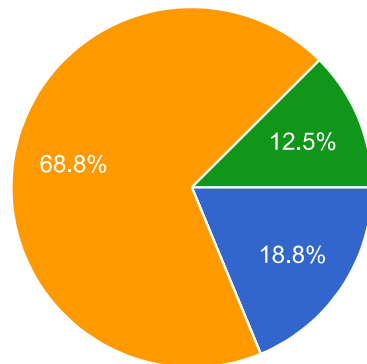


- B, 1/10, A-40

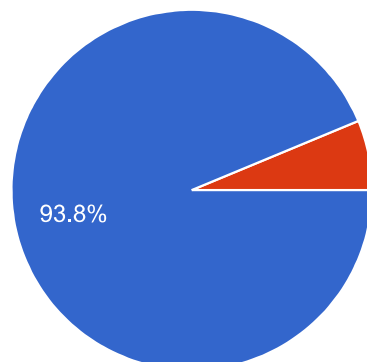

## What would you tell the coach of the fouling team

personal foul on 25 coach

The ball was dead as soon as the kick ended as a result of the fair catch

Result of the play foul on K25. Tackled R34 after the fair catch.

#25 UNS following a fair catch

A fair catch signal was given

#25 tackled the receiver after the fair catch. clock starts on the snap

Ball becomes dead after valid fair catch is CAUGHT. KCI - 15 yards

The play is dead after a completed fair catch. Penalty will be assessed at the point of contact first down K

The play ended after the catch was secured.

Coach, it was ruled that after the receiver caught the ball, which is dead immediately, your player illegally contacted the receiver so it will be a dead ball foul administered from the spot of the catch. Their ball 1/10.

K25 Tackle after fair catch dead ball foul

K #25 committed KCI after a legal fair catch signal and successful catch by R.

Player 25 tackled the returner after making a fair catch.

## What would you tell the coach of the fouled team?

personal foul on 25 coach

The ball was dead as soon as the kick ended as a result of the fair catch

Result of the play was a foul on K25. Accept the penalty at the spot of foul or previous spot and replay down.

#25 UNS following a fair catch

15 YArD personal foul.

KCI, 15 yards, 1st and 10, clock is stopped, restarts on the snap

Do you want 15 yard penalty from spot of foul or 15 yard penalty and replay the 4th down?

The play is dead upon a completed fair catch when the official blows his whistle. First and 10 after penalty assessment.

The play ended when the catch was secured.

The dead ball foul will be administered from the spot of the catch. No options.

Dead ball foul - Penalty after Fair catch

KCI committed by K at XX yard line; it will be a 15-yard penalty from the spot of the foul.

This was a dead ball penalty and will be assessed from the spot of the foul.

Personal foul, UNR by the kicking team. It will be your ball at the (end of the kick plus 15yds)

## What would you report to the Referee?

after the catch dead ball personal foul kicking team 25.

After the kick, dead ball, unsportsmanlike conduct #XX of the Kicking team at the spot of the foul (no spot given in scenario), 15 yards, report flagrant if necessary

During the down and result of the play. I have KCI on K25.

After the fair catch, UNS #25 K, 15 yards, 1/10 R (no yard line given)

Dead ball fault, personal foul on kicking team for a tackle after a legal fair catch. 15 yards from the spot of the fair catch

KCI, #25K, 1st down, clock is stopped, restarts on the snap

After the kick, Dead ball, KCI, Kicking #25. R coach has options.

Fair catch completed then tackled by kicking team. Receiver did not try to advance the ball.

A proper fair catch signal was given and the ball was caught, therefore ending the play.

The result of the play was a fair catch. After the play, dead ball personal foul kicking team #18.

K25 Ignored Fair Catch dead ball foul

Result is a fair catch by R; After the catch, KCI by K #25 at the XX yard line where my flag is.

The kick ended with a fair catch. After the play, K25 tackled the returner.

After the fair catch, UNR #X from the kicking team. We are on the snap

After the play, personal foul on K-##. 15 yard penalty will be added on to the end of the play.

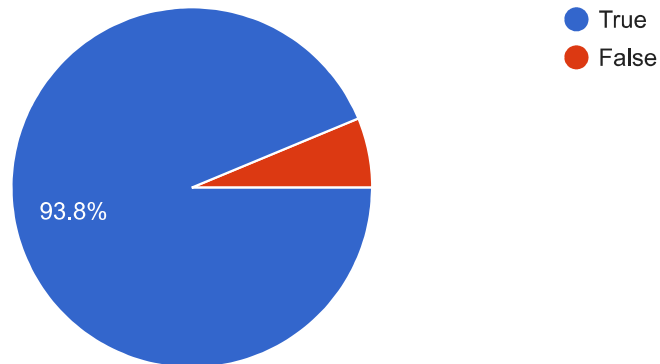
After legal fair catch, dead ball foul for tackling R after the catch

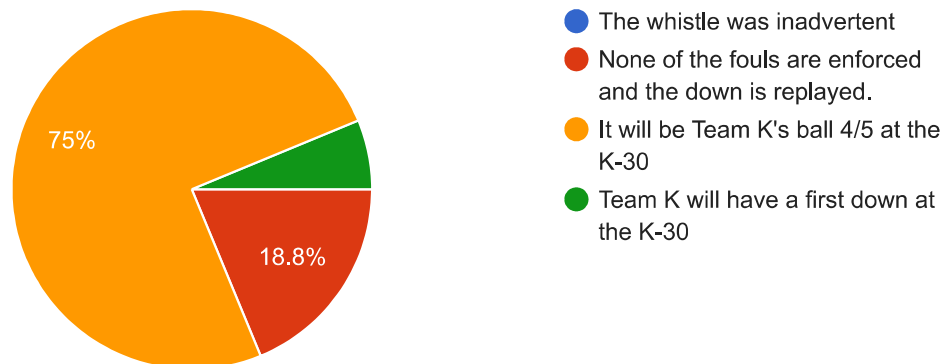

A, 4/20, K-15. K27 punts the ball and replaced player R76 is flagged for not getting off the field before the snap. R34 catches the punt and has his helmet pulled off by K84 on an attempted tackle. R34 remains standing and the whistle is blown. R55 then retaliates against K84.

## What do you tell the coach of K?

coach live ball fouls off set. then dead ball foul on R 15 yrd penalty it will be 4th down and replay of the down.

live ball fouls by each team offset, dead ball unsportsmanlike makes it 4/5 @ K 30

Result of the play. Double fouls will offset. Foul on R55 will be enforced.

offsetting penalties, replay the down

Multiple fouls, offset, replay the down

We have illegal participation on R76 for not getting off the field in time, followed by a PNS for grabbing the facemask on your #84 during the attempted tackle. During that missed tackle, we had an inadvertent whistle, followed by a PNS on R55 on #84. The inadvertent whistle kills the play before the retaliation by R55 on your #84. That is a 15 yard penalty administered from the LOS. we will replay 4th down from the k-30. The clock is stopped and will restart on the snap

Two penalties occurred on R. Illegal substitution, play ends, then dead ball personal foul for the retaliation.

The two penalties off set. Then the dead ball personal foul occurred which will result in 4/5

The play ended as soon R34's helmet came off. During play offsetting penalties, dead ball personal foul on R makes down 4/5 from K30

The two live ball fouls will offset and we will replay the down. But, #55's dead ball personal foul will be enforced making it 4/5 at the 30-yard line.

UNS on R55 - 15 yrd replay 4th

There is a live-ball foul by each team and it is a double-foul and the penalties cancel; illegal substitution foul, R76 and a live-ball personal foul, K84 for pulling off the helmet. After the play, there was a dead-ball UNS foul, R55. K4/5, K30.

There was a penalty for too many men on the return team and a facemask by your player #84. Those penalties will offset. After the play we have a personal foul called on their player #55. The penalty yardage will not be enough for a first down.

There are multiple fouls on the play. Live ball fouls by both teams so we will replay the down, and a dead ball foul by R55. This foul will be assessed and it will still be 4th down.



Illegal substitution on R-76. Facemask on K-84. those penalties offset. After the play, unsportsmanlike conduct on R-55. Do you want to accept the result of the play, or replay 4th down?

Result of the play. Foul on R55 for retaliating. Double fouls offset.

Multiple offsetting fouls, replay the down

We have illegal participation on your #76 for not getting off the field in time, followed by a PNS for grabbing the facemask on K84 during the attempted tackle. During that missed tackle, we had an inadvertent whistle, followed by a PNS on your #55 on K84. The inadvertent whistle kills the play before the retaliation by your #55 on K84. That is a 15 yard penalty administered from the LOS. we will replay 4th down from the k-30. The clock is stopped and will restart on the snap

Two penalties occurred on R. Illegal substitution, play ends, then dead ball personal foul for the retaliation.

The initial two penalties offset. Then the personal foul occurred during a dead ball and will be assessed.

The play ended as soon R34's helmet came off. During play offsetting penalties, dead ball personal foul on R makes down 4/5 from K30.

UNS on r55 - Replay 4th

There is a live-ball foul by each team and it is a double-foul and the penalties cancel; illegal substitution foul, R76 and a live-ball personal foul, K84 for pulling off the helmet. After the play, there was a dead-ball UNS foul, R55. K4/5, K30.

Your penalty of too many men on the field and the facemask by their team will offset. However, your player #55 is penalized for a personal foul. We will be replaying 4th down.

There are multiple fouls on the play. Live ball fouls by both teams so we will replay the down, and a dead ball foul by #55. This foul will be enforced and it will still be 4th down for the other team.



Illegal substitution on R-76. Facemask on K-84. those penalties offset. After the play, unsportsmanlike conduct on R-55

## What do you report to the Referee?

16 responses

fouls by both teams 2 live ball penalties and a dead ball foul on R.

During the kick, illegal substitution on R76, during the return, 15 yard facemask on K84. The helmet came off of R34 causing the play to be whistled dead. After the play was over, unsportsmanlike conduct on R55. Live ball fouls offset, dead ball UNS makes it K 4/5 at K 30

During the down. Foul on R76 SUB and K84 UNS. After the play foul on R55 UNR.

Before the snap, R 12 players on the field; during the play, face mask K84; after the play UNS R55

Illegal substitution, facemask, and dead ball personal foul. Offset, replay the down

We have illegal participation on R76, followed by a PNS for grabbing the facemask on K84 during the attempted tackle. Then, we have a missed tackle and an inadvertent whistle, followed by a PNS on your R55 on K84. We will replay 4th down from the k-30. The clock is stopped and will restart on the snap

Prior to the kick, Illegal substitution, R-34. Runner's helmet came off. After the play, personal foul, retaliation from R55.

During the play, illegal substitution on the kicking team and unsportsmanlike conduct on the receiving team which will offset. Then dead ball foul unsportsmanlike conduct number 55 of the receiving team.

The play ended as soon R34's helmet came off. During play offsetting penalties, dead ball personal foul on R makes down 4/5 from K30.

We have three fouls on the play. During the kick we had two live ball fouls. Illegal substitution receiving team #76, and facemask kicking team #84. Illegal substitution is not a PSK foul so the two live ball fouls offset and we will replay the down. Dead ball personal foul receiving team #55, 15-yards. 4th down.

12 man on field on /Facemask on K/Dead Ball on K

Result is a catch by R34; when K tackled R, live-ball personal foul K84 for pulling helmet off. Play was blown dead. Additionally, Illegal Substitution, live-ball foul at the snap by R76, who did not make it off the field in time. After the whistle, dead ball UNS foul by R55 against K84.

Before the kick, the return team had too many men on the field - return team #76. During the run, facemask by kicking player 84. After the play #55 of the return team hit a player of the



kicking team

Result of the play is a run inbounds. Multiple fouls during the play, illegal substitution by #76 of the receiving team and personal foul - facemask, #84 of the kicking team, these fouls offset. After the play, personal foul, UNR #55 of the receiving team. This foul will be enforced and it will still be 4th down. We are on the ready.

Illegal substitution on R-76. Facemask on K-84. those penalties offset. After the play, unsportsmanlike conduct on R-55

2 fouls on the play. Illegal participation on R76 and a dead ball foul on R55
