

The play was over when the foul occurred. Player #45 is disqualified and the 15-yard penalty will be enforced on the 2nd half kickoff.

personal foul on number ##

Dead-ball foul. Penalty will be enforced on the first play of the 2nd half. Player is ejected.

player DQ, be enforced on kickoff

UNS on #(fill in number). The player is disqualified.

Foul for fighting. The defender threw a punch after the play had ended. We'll enforce the distance penalty on the second-half kickoff.

Coach, after the play, we had a dead ball personal foul penalty on defensive player #45. The foul happened after the play and will be assessed on the second half kickoff. Player #45 is disqualified and cannot return to the game.

Your player is ejected for throwing a punch, the period is extended for an untimed down

After the play, number ## punched an opponent. Foul should be assessed on the second half kickoff

Dead-ball foul by #Bxx. Punch to the runner after the play was over. Penalty should be enforced after the half.

Def player threw punch, have another in crew back up the ruling DQ player

After the time for the half expired, UNS defense #(fill in number). He threw a punch, we should consider DQ.

After the play, 45 on the defense threw a punch.

We had a run in bounds for a first down and the clock is now at zero. After the play, defensive player #45 punched offensive player #21 in the face.



What would you report to the Referee?

Live ball substitution foul, defense, #53. The non-player foul will be tacked on.

Runner was short of the line to gain. During the play, illegal substitution on defense ##. Will result in a first down and the clock starts on the ready

Illegal substitution. Live ball foul. Team B substitute entered the field of play after the ball was snapped.

Live ball foul, illegal sub; 5 yrds from the end of the run

The result of the play is a run in bounds short of the line to gain. During the play, illegal substitution on the defense #(fill in number). 4th down. We are on the ready.



What would you say to the coach when he requests the time-out?

Coach, your QB must remain out of the game for one play.

Your QB still cannot play for at least 1 down. Do you still want to use your time out?

QB1 will still have to sit out one play. Do you still want it?

Player can enter after bleeding has stopped if a TO is called

The QB will still need to sit out a play, the timeout does not buy him back in.

Since we sent the player off, he must stay out for one down.

Coach, the player must be substituted for one play and cannot return even after a timeout is called.

OK

Coach, You've got 1 minute to fix him up or else you have to substitute

A bleeding player is only required to leave until the bleeding is stopped and is not required to stay out for at least one down.

QB was sent off the field and must sit out a play.

1 minute Coach

I'm sending your injured Player to the sideline. He is bleeding from the nose. Calling a timeout won't allow him to return for this play.

QB must remain out for 1 play

QB, is still an injured player, must be out for at least one play

The referee stoped the game- sit out one play. Time out is charged

Accept the time-out. QB bleeding needs to be stopped and cleaned up before returning to the game.



□ Copy K, 4/6, K-28. Team K is in a scrimmage kick formation. Immediately after the snap, a kicker holds a receiver at the LOS. The punter kicks the ball. It is caught by a receiver at the 50 and returned to the K-45. Team R accepts the penalty. 17 responses K, 4/16, K-18. Clock starts on 52.9% the ready K, 4/16, K-18. Clock starts on the snap R, 1/10, K-35. Clock starts on the ready R, 1/10, K-35. Clock starts on the snap A or C 29.4% A or D

Coach, the 10-yard penalty can be assessed at the previous spot and replay 4th down, or we can tack it on to the return.

Holding on number ##

Holding on K. Would you like to enforce the penalty from the end of the run or enforce and have K rekick from the new spot?

Rekick or accept penalty from end of the run

Holding on #(fill in number), would you like to have them re-kick or tack it onto the return?

Holding on kicking team coach elects rekick or from end of run

Result of the play is a return inbounds. During the kick, Holding, kicking team #(fill in number). The receiving team has elected to tack the penalty onto the return. 1st down.

During the kick, hold by the kicking team at the LOS, the run ended at the 45 yard line.
