

Ensure that the bal be spotted at the previous spot as to ensure there is not advantage gained (the length of the football)

confirm no penalty and change of possession with R and set chains

Stop clock. Ensure box hasn't moved. Once ball is spotted back at LOS, reset box and chains for team B.

Stop the clock and mark the location of the ball.

Make sure the chains/down box are placed correctly

Signal incomplete pass and stop the clock signal. Look to the referee to move the chains for new series for B. 1st and 10.

resetting chains and getting new ball if needed

Keep the current spot and reset chains

Once no penalties on the play is clear, make sure the box remains at the exact spot and then moves forward 11 inches as the ball placement remains the same.

Hold the chains at the 4th down spot until the ball is properly set. Then move the box 11 inches and reset the chains 1/10 going the other way.

Hold the LoS spot

reset chains to account for the 11 inches

Stop the clock, verify with the ref then reset chains the other way.


Ensure the chains get reset appropriately. Ball gets set in the sam spot....new line to gain is set up from the new front of the ball. 12 inches in the other direction.






